# PERKO FIG. 1643 LIGHTSHIP 300 SERIES HIGH PERFORMANCE LED FLOOD/SPOT LIGHTS **INSTALLATION INSTRUCTIONS**

#### **READ ALL DIRECTIONS BEFORE PROCEEDING**

- Examine mounting template, and choose appropriate mounting location.
- Orient the template so that desired illumination is achieved, then use the template to drill mounting and wiring holes.
- This is a DC light. You should only power it directly using a DC source. The light will auto detect the DC voltage.
- Connect:
  - a. White wire to Positive (+) supply.
  - b. Black wire to Negative (-) supply
  - c. Dimming wires (thin white and thin black) left unconnected for max brightness. For dimmable operation, consider a 10K Ohm potentiometer across these wires (not included).
  - d. Green wire (ground) to chassis ground (metallic element that is tied to vessel chassis).
- All wire connections including the open end of the cable jacket MUST BE protected from water intrusion. Otherwise, damage due to water ingress, short circuits, or corrosion will not be covered by the warranty.

#### A Note on Cable Length:

- If you operate at 12V, the current draw will be approximately 26A. The 6ft cable that comes out of the light (i.e. the pigtail) is AWG12 and if you <u>also</u> plan to use AWG12, your <u>total</u> cable run <u>MUST NOT</u> exceed 10ft. This is to minimize voltage drop to the light. If your light looks dim or if it flickers, the most likely cause is an insufficient cable gauge or the cable run is too long. (See A.B.Y.C. Standard E-9\*)
- If you plan to do a longer cable run, we recommend you to first run the pigtail to a waterproof junction box close to the light, then run AWG10 or AWG8 to your DC power source depending on the overall length.
- If you are operating on 24V, the light will draw roughly 18A. AWG14 gauge should suffice for an entire run up to 30ft.
- Make electrical supply connections in accordance with A.B.Y.C. Standard E-9\* and U.S. Coast Guard Safety Standards for Boat Electrical Systems\*.
- Fasten to deck with 1/2" and/or 3/8" bolts as shown in the diagram.








# **MOUNTING BRACKET HOLE TEMPLATE (TO SCALE)**

Drill 1/2" hole for electrical cable Drill for 3/8" bolt (2x) (for fixed mount)






